- Total dues **may change based on any dues increase by South Shore Realtors®, the National Association of Realtors® and/or Massachusetts Association of REALTORS®**. If dues increase, I will be notified and the difference will be collected in the second installment payment.
- If any dues payment installment is declined, I will provide South Shore REALTORS® with an accepted credit card **within 24 hours**.
- **If my total dues are not paid in full by January 1, 2020, a late fee of \$75 will be assessed.**
